The HEAL Innovation Fund has been established to support interdisciplinary research on the interaction between the environmental, climate change, and health by funding well-defined projects that include community and stakeholder co-design and that have the potential to lead to further external funding.

The 2025 seed funding on offer will support projects worth up to \$30,000 each, for a period of 12 months. #### PLEASE NOTE

HEAL Chief, Associate and Affiliate Members can participate as Principal Investigators or Co-Investigators in proposals. Applications (1) <u>must</u> be led by an Early to Mid-Career Researcher (EMCR); (2) include at least one HEAL Network Chief or Associate Investigator; (3) <u>must</u> include at least two HEAL Network partner organisation; and (4) collaboration between HEAL themes/Communities of Practice is encouraged.
